Physical Education, Bhartiya Krida Mandir, Wadala, Mumbai, Maharashtra vide order No. WRC/5-6/96/6423-6425, dated 23.11.1998. For conducting the B.P.Ed. course with an annual intake of 120 seats.

And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the B.P.C.A'S College of Physical Education, Bhartiya Krida Mandir, Wadala, Mumbai, Maharashtra offering B.P.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

And whereas, after the receipt of affidavit dt. 13.01.2015 from the institution, a revised recognition order no. WRC/APW0117/114031/B.P.Ed (Revised order)/2015/147103-110 dt. 31.05.2015 was issued to the institution for conducting B.P.Ed. Programme of two years duration with an annual intake of 100 seats (two basic units of 50 students) from session 2015-16.

And whereas, the WRC vide revised recognition order dt. 31.05.2015 had directed the institution to submit the followings documents in compliance of the NCTE Regulations, 2014:-

- 1. List of teaching staff, duly approved by the affiliating body, appointed by the institution for each course.
- 2. Proof of maintaining the Endowment fund and Reserve fund as per NCTE Regulations, 2014.
- 3. A duly notarized building completion certificate (BCC) issued by the competent authority.

And whereas, the matter was placed before the WRC in its 255th meeting held on June 22–24, 2016 and Committee decided to issue Show Cause Notice dt. 12.08.2016.

And whereas, reply of show cause notice was not submitted by the institution and the matter placed before the WRC in its 283^{rd} meeting held on November $14^{th} - 15^{th}$, 2017 and the Committee decided as follows:

"The case file was seen. Since reply to Show Cause Notice dated 12.08.2016 has not been received, Recognition is withdrawn from the academic session 2018-2019. FDRs, if any, be returned.

Hence, Recognition is withdrawn from the academic session 2018-2019."

Now, therefore, the recognition of B.F.C.A'S College of Physical Education, Bhartiya Krida Mandir, Wadala, Mumbai, Maharashtra for conducting B.P.Ed. programme of two years duration with an annual intake of 100 seats (two basic units of 50 students), is hereby withdrawn from the academic session 2018-2019 in terms of Section 17(1) of the NCTE Act, 1993.

Revised Order

Whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- 2. And whereas, the Bombay Physical Association College, College of Education, Bhartiya Krida, Mandir, Niagaon Cross Road, Wadala, Mumbai, Maharashtra by affidavit dt. 13.01.2015 has consented to come under new Regulations and sought for one basic unit in **B.P.Ed.** which require additional facilities.
- 3. And whereas, it has been decided to permit the institution to have one basic unit of 100 students each subject to the institution fulfilling following conditions namely,
 - The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
 - II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
 - III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
 - IV. In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted along with the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.
- 4. Now therefore, in the light of the above and in accordance with the NCTE Regulations, 2014, the Western Regional Committee (NCTE) hereby issues the revised recognition order to Bombay Physical Association College, College of Education, Bhartiya Krida, Mandir, Niagaon Cross Road, Wadala, Mumbai, Maharashtra for conducting B.P.Ed. programme of two years duration with an annual intake of 100 students (one basic unit of 100 students) from the academic session 2015-16 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.
- 6. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.
- 7. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

a) Sanctioned programmes along with annual intake in the institution:

b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

c) Name of faculty members who left or joined during the last, quarter:

d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;

e) Fee charged from students;

f) Available infrastructural facilities;

g) Facilities added during the last quarter;

Number of books in the library, journals subscribed to and additions, if any, in the last quarter;

i) The affidavit with enclosure submitted along with application.

i) The institution shall be free to post additional relevant information. if it so desires.

k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.


